RETURN-IT

Thank you for you interest in the Victoria's Container Deposit Scheme (CDS Vic)

- By registering your organisation for the scheme, you can raise funds in a new way and help the environment.
- This scheme launches November 1, 2023
- For every eligible drink container return, you can receive a 10c refund
- By registering as a donation partner, people can choose to donate their refund to your organisation in a number of different ways, including via zone app, sharing your Donation Partner ID (or barcode) or using a handy search function on the CDS-Vic website (coming soon).
- Once registered you can host your own collection drive, by encouraging your members and supporters to collect and deposit the containers to your organisation.

Step 1

Register with CDS Vic



You will be able to obtain your Donation Partner ID by completing our registration form. You will require a valid ABN.

If you are not registered with an ABN, you may need to provide a statutory declaration.

Sign Up As A Donation Partner \rightarrow

STEP 1: Click on this link: <u>https://cdsvic.org.au/donation-partner-registration</u> You will need:

- Organisations contact email
- ABN
- If you don't have an ABN you will need to sign a statutory declaration declaring you are either a registered entity or a school or a sporting, community, education or environmental body

Once you have registered with the CDS-Vic, you should receive an email with a donation partner ID and a link to register through Return-It's member Portal.

Be aware that if you are a State-wide organisations you may wish to activate with all three Zone Operators.

RETURN-IT Activate your ID with a Zone Operator

STEP 2: Follow the link provided in the email from CDS-Vic, or by clicking this link <u>Return-It Sign Up</u>

You will need to enter your credentials to create an account and set a new password This will be your organisations contact email.

A verification email will be sent to the inbox for the email account you provided.

Click on the link in this email to verify your email address.





STEP 3: Make sure to select "As a Donation Partner" to continue your sign-up journey

STEP 4: Enter the Donation Partner ID that was provided



in the email form CDS-Vic when you have completed the registration process with them.

You're registering your organisation as a Done Partner with the CDS Vic East network, opera by Return-It

Confirm Donation Partner ID

This ID was sent to you by CDS Vic in your donation partner confirmation email. A Dona Partner ID is an 11 digit alpha-numeric ID.

2. Demonstrate the following:

a. a community benefit within Victoria or Australia;
b. a willingness to use its own networks and resources to promote awareness of its presence on the VIC CDS scheme to mutual advantage;
3. The organisation has been operating for 3 years and is reputable and of good standing in the community.

4. The organisation must not be:

a. a political party or an organisation associated with current political issues or political activism;

RETURN-IT Download the app – CDS- VIC EAST

- The CDS-VIC East app is on all App stores from October 1.
- You will need to sign up and confirm your email address via your email account.
- You will also need to select what account you would like your refunds to be awarded to.
- Once you have confirmed these details, log out and log back into your account to receive your ID number and barcode.
